

“Discover the world with SKAT” CONTEST TERMS AND CONDITIONS

§1. General provisions

1. The “Discover the World with SKAT” contest (hereinafter referred to as “the Contest”) is organised by SKAT Transport spółka z ograniczoną odpowiedzialnością sp.k. [limited liability limited partnership] with its headquarters in Gdańsk at ul. J. Słowackiego 199, 80-298 GDAŃSK, entered into the Register of Entrepreneurs of the National Court Register maintained by the District Court for Gdańsk-Północ in Gdańsk, VII Commercial Division of the National Court Register under National Court Register (KRS) number 487902, Tax Identification Number (NIP): 5851356886, and National Business Register Number (REGON): 191909392, as well as the organiser’s ferry website PromySkat (www.promyskat.pl), hereinafter referred to as the ‘Organiser.’
2. The Organiser declares that the Contest is not a game of chance or a mutual bet within the meaning of the Gambling Act of 19 November 2009 (OJ 2009, no. 201, item 1540, as amended).
3. The award donor is the Organiser’s Partner for the given edition of the Contest, indicated in each case in Annex 15.
4. The Contest is organized on the territory of the Republic of Poland.
5. Before taking part in the Contest, the user should read these Terms and Conditions.
6. The Organiser shall appoint a contest committee (hereinafter the “Committee”) whose task will be to ensure the proper conduct of the Contest and to select the winners in the Contest.
7. The aim of the Contest is to promote non-commercial travel activities as well as amateur and professional photographic work and to make participants’ most interesting work available to the public during post-contest exhibitions.

§2. Place and duration of the Contest

1. The Contest is organised and conducted on the website www.poznajswiatzeskat.pl, which is administered by SKAT Transport sp. z o.o. sp. k. [LLLC].
2. The Contest consists of separate editions, with individual editions lasting up to 30 days announced every two months during the tourist season. The contest is conducted using the contest module available during a contest edition at www.poznajswiatzeskat.pl.
3. Each edition of the Contest ends with the winner being selected.
4. Each edition consists of two stages. The first stage of each contest edition lasts 20 days, while the second stage - selecting the winner - lasts up to 7 days.
5. Information on the duration of individual editions and prizes can be found in the annexes to these Terms and Conditions.

§ 3. Conditions for participation in the Contest.

1. The Contest Participant must be a natural person, an adult, having full legal capacity, residing on the territory of Europe.
2. Only natural persons engaged in amateur and professional photography may participate in the Contest, excluding the Organiser’s employees. Participants enter the Contest through the contest

module at www.poznajswiatzeskat.pl from the moment the module is launched for each subsequent edition. The submission is considered valid if all required fields are completed in the submission form.

3. One participant may post **only one work (photo) in each edition of the contest, and works submitted to the Contest may not be processed electronically or be a photomontage.**

4. The submission should include the name, surname, current e-mail address, telephone number, and the work of the person taking part in the Contest, as well as a description of the photo in accordance with the guidelines provided on the poznajswiatzeskat.pl website and in these Terms and Conditions. Submissions not containing these elements will not be admitted to the Contest.

5. The contest entry includes a work which presents the essence of traveling in photography. The photo should reflect the pleasure and passion of traveling and show both interesting locations and the emotions related to travel and holidays, e.g. unforgettable landscapes, interesting buildings and locations or portraits, self-portraits, or group self-portraits with people encountered while traveling. The photo can be taken using any technique, using any electronic equipment: a camera, a mobile phone, a smartphone.

6. Sending a fully completed contest form together with a proposed photo constitutes a submission to the Contest (hereinafter referred to as "Submission"). In the Contest, only complete submissions which are in accordance with the contest task, contain no illegal content, do not endanger the rights of third parties, do not violate good morals, do not discriminate on the basis of race, sex, age, sexual orientation, nationality, political or religious beliefs, disability, do not violate human dignity, do not depict violence or hatred, and contain no content of an erotic, pornographic, or vulgar nature, and which fulfil all conditions set forth in these Terms and Conditions will be taken into account.

7. The Contest Participant who wins will receive notification via e-mail or telephone.

§ 4 Personal data

1.1 Controller of personal data

1.2 Purposes and legal basis of the processing of personal data

Personal data are processed for the following purposes, based on legal grounds and for the periods indicated below.

1.2.1 Participation in the Contest

Personal data: name, surname, e-mail address, telephone number, image, and in the case of winners, date of birth, PESEL number, name, and surname, and for persons participating in the ferry crossing, PESEL number and date of birth.

Legal basis: art. 6 (1) (a) of the GDPR, i.e. based on the consent of the Contest Participant to the processing of personal data.

Purpose of processing: participation in the “Discover the World with SKAT” contest.

Data storage period: until the date of withdrawal of consent for the processing of personal data.

1.2.2 Publication of photos on the Data Controller’s websites, in an exhibition organised by the Organiser, and on the Data Controller’s social media profiles

Personal data: name, surname, image.

Legal basis: art. 6 (1) (a) of the GDPR, i.e. based on the consent of the Contest Participant to the processing of personal data.

Purpose of processing: Publication of photos on the Data Controller’s websites and on the Data Controller’s social media profiles

Data storage period: until the date of withdrawal of consent for the processing of personal data.

1.2.3 Examining complaints and requests, and answering queries

Personal data: name, surname, e-mail address, phone number, residential address

Legal basis: examining complaints and requests and answering queries

Purpose of processing: art. 6 (1) (f) of the GDPR, i.e. processing for the purposes of the legitimate interests pursued by the Data Controller, which are to improve the quality of its services and build positive customer relations

Data storage period: up to the day of expiry of 3 years from the date of the last communication with the data subject.

1.2.4 Compliance with the legal obligations to which the Data Controller is subject under tax and accounting laws

Personal data: name, surname, PESEL number, tax identification number (e.g. NIP or REGON), and date of birth of the winner or ferry crossing participant, mailing address.

Legal basis: Art. 6 (1) (c) of the GDPR, i.e. processing is necessary for compliance with the legal obligations to which SKAT Transport is subject under tax and accounting laws.

Purpose of processing: compliance with the legal obligations to which SKAT Transport is subject under tax and accounting laws.

Data storage period: until the expiry of the limitation period.

1.3 Voluntariness of the provision of personal data

The submission of the required personal data by the Contest Participant is voluntary and is a condition of participation in the Contest.

1.4 Categories of personal data concerned:

The Data Controller shall provide information about the following categories of relevant personal data:

- contact information,
- image.

1.5 Sources of personal data:

Personal data processed by the Data Controller come from the data subject or from the Contest Participant.

1.6 Recipients of personal data

1.7 What rights do you have in relation to our processing of your personal data?

Based on the GDPR, the data subject has the right to:

- request access to your personal data
- request correction of your personal data
- request erasure of your personal data
- request limitation of the processing of your personal data
- object to the processing of your personal data
- request transfer of your personal data

In the event that any of the above-mentioned requests are reported to the Data Controller, the Data Controller shall without undue delay - and in any case within one month of receipt of such request - provide information on the actions taken in connection with said request.

If necessary, the Data Controller may extend the response period by another two months due to the complex nature of the request or due to the number of requests.

In any case, the Data Controller shall provide information on its extension of the response period within one month of receiving the request, and shall give reasons for the delay.

1.7.1 Right of access to personal data (art. 15 of the GDPR)

The data subject has the right to obtain information as to whether the Data Controller processes his/her personal data.

If the Data Controller processes your personal data, you have the right to:

- access personal data,

- obtain information on the purposes of the processing, the categories of the personal data being processed, the recipients or categories of recipients to whom the data are disclosed, the envisaged period for which the personal data will be stored or the criteria used to determine that period, your rights under the GDPR and the right to lodge a complaint with the President of the Office for the Protection of Personal Data (Urząd Ochrony Danych Osobowych), the source of the data, the existence of automated decision-making, including profiling, and any safeguards applied where the personal data are transferred outside the European Union;
- obtain copies of your personal data.

1.7.2 Right to rectification of personal data (Article 16 GDPR)

If your personal data are incorrect, you have the right to request that the Data Controller immediately correct your personal data. You also have the right to request the supplementation of your personal data by the Data Controller.

If you intend to request correction or supplementation of your personal data, please submit a request to: marketing@skat.com.pl

1.7.3 Right to erase personal data, the so-called 'right to be forgotten' (art. 17 of the GDPR)

You have the right to request the erasure of your personal data if:

- your personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;
- you have withdrawn specific consent to the extent to which your personal data were processed based on consent;
- your personal data have been unlawfully processed;
- you have lodged an objection to the processing of your personal data for the purposes of direct marketing, including profiling, to the extent to which the processing of personal data is related to direct marketing;
- you have objected to the processing of your personal data in relation to the processing necessary for the performance of a task carried out for reasons of public interest or for the purposes of the legitimate interests pursued by the Data Controller or by a third party.

Despite your request for deletion of personal data, the Data Controller may further process your data in order to determine, assert, or defend claims, about which you will be informed.

1.7.4 Right to request limitation of personal data processing (art. 18 of the GDPR)

You have the right to request the restriction of the processing of your personal data if:

- you question the accuracy of your personal data - in this case, we will limit the processing of personal data for a period allowing for verification of the correctness of these data;
- the processing is unlawful and you oppose the erasure of your personal data and instead request the restriction of their processing;

- your personal data is no longer needed for processing purposes; however, they are required by you for the establishment, exercise, or defence of legal claims;
- when you have objected to the processing of your personal data - pending determination of whether the legitimate interests of the Data Controller override the grounds indicated in the objection.

1.7.5 Right to object to the processing of personal data (Article 21 GDPR)

You have the right to object, at any time, to the processing of your personal data, including profiling, in connection with:

- processing necessary for the performance of a task carried out for reasons of public interest or for the purposes of the legitimate interests pursued by the Data Controller or by a third party;
- processing for direct marketing purposes.

1.7.6 Right to request transfer of personal data (art. 20 of the GDPR)

You have the right to receive your personal data from the Data Controller in a structured, commonly used and machine-readable format and have the right to transmit those data to another data controller.

Normally, the Data Controller provides personal data in CSV format, but if the data is to be made available in a different format, please indicate the preferred format in your request.

If possible, the Data Controller will try to provide data in the indicated format.

You may also request that the Data Controller send personal data directly to another data controller (if technically possible).

1.8 Right to withdraw consent

You have the right to withdraw your consent to the processing of your personal data at any time.

The withdrawal of consent to the processing of personal data does not affect the lawfulness of their processing by the Data Controller based on your consent before withdrawal thereof.

1.9 Complaint with a supervisory authority

If you consider that the processing of your personal data infringes the data protection laws, you have the right to lodge a complaint with a supervisory authority, in particular in the Member State of your habitual residence, place of work or place of the alleged infringement.

In Poland, the supervisory authority within the meaning of the GDPR is the President of the Office for the Protection of Personal Data (Urząd Ochrony Danych Osobowych), which replaced the Inspector General for Personal Data Protection (GIODO) as of 25 May 2018.

§ 5 Copyright

1. By sending a submission to the Contest Organiser, the Participant agrees to provide the Contest Organiser with a **non-exclusive license** without any time, quantity, or territorial restrictions for all fields of exploitation known at the date of submission to the Contest, in particular:

- a) the right to make a digital record of works,
- b) publish works on the Internet,
- c) the right to save works in computer memory and the Organiser's own databases,
- d) production of specific copies of the work, including printing, reprographics, magnetic recording, and digital techniques,
- e) multiplication and dissemination of the work (including on the Internet), including on any audio-visual media, in particular on a magnetic medium and a computer disk and all types of media intended for digital recording,
- f) the right to perform computer processing and to make changes and modifications to works required by the specificity of the Internet medium;
- g) the right to publicly perform and broadcast and publicly share works on the Internet in such a way that everyone can have access to such works in a place and time chosen by them, regardless of the type and operation of the device or applications used.

2. The participant consents to the publication of photos on:

- websites administered by the Organiser,
- on social media administered by the Organiser on the websites and social media of the Contest Partners and Contest Media Patrons, providing their first and last name and stating that they give the Contest Organiser a **free non-exclusive license** for promotional, informational and advertising purposes related to the "**Discover the World with SKAT**" contest.

Submitting works for the contest is tantamount to a declaration that the images do not violate personal and material rights and copyrights of third parties and the image rights of persons depicted therein, were made by the person submitting the work, portrayed persons who consent to the publication of their image.

3. Liability for the violation of third party rights, in particular proprietary copyrights associated with the Contest Submission, shall be borne by the Contest Participant who submitted the Submission to the Contest on the terms set out in applicable law.

4. The Organiser promises the prize in accordance with art. 919 par. 1 of the Civil Code. According to art. 921 § 3 of the Civil Code, at which time the Contest Winner is awarded, the Organiser acquires proprietary copyrights to the winning Contest Submission of the Contest Winner as well as the right to disseminate developments thereof in all countries of the world without time limits, in the following fields of exploitation: recording, including recording on material IT media (incl. CD-ROMs, DVDs, magnetic tapes, magneto-optical media), reproduction by any technique, including reproduction by printing, market, saving to computer memory, dissemination on the Internet or other computer or teleinformatic networks, public performance or reproduction, transmission using magnetic tapes and magneto-optical media, satellite broadcasting, public display, creation and distribution of dependent works, modification, including the right to correct, change, alter, and adapt the whole and its individual parts, rent, lease, place on goods or their packaging and market

such marked goods or packaging, use in all forms of advertising, register as a trademark in Poland and abroad, broadcasting video or audio via a wired network or wirelessly via a terrestrial station (also via a cable or coded television network), use in the field of promotion and advertising.

5. Contest Winners are not entitled to remuneration for the transfer of propriety copyrights to the winning Contest Submission referred to in point 4 above. Receiving a Prize in the Contest exhausts in full the financial claims of the Contest Winner resulting from the above.

6. The Participant authorizes the Organiser to decide on the designation and method of marking the above-mentioned photography.

7. The Organiser is not obliged to use the above-mentioned photographs in any of the exploitation fields listed above.

§ 6. Contest rules

1. The Contest runs from 00:00 on the date of publication of individual editions to 23:50 on the 20th day of the month until the announcement of the winner. Submission to the Contest takes place by completing the form in the contest module located at www.poznajswiatzeskat.pl and uploading a work on the given topic after becoming acquainted with the Contest terms and conditions.

2. When submitting, it is necessary to provide the following data: **name and surname, e-mail address and telephone number**. E-mail address **or phone number** will be used only for communication related to the Contest. Contact with the Contest participant will take place via the provided e-mail address or by phone.

3. Once completed, a submission cannot be changed.

4. One submission includes one photo.

5. Photographs may not be processed electronically or be photomontage.

6. A Contest Participant may submit only one photo in each contest edition.

7. The photography must strictly refer to the subject.

8. The Organiser has the right to verify the copyrights to the submitted image.

9. At every stage of the Contest, the Organiser may exclude from the Contest participants who violate the provisions described in these Terms and Conditions after an unsuccessful request to cease violation within 3 days from the date of receipt thereof by e-mail from the Organiser. A participant excluded from the Contest in accordance with the above provisions cannot submit again. The Contest Committee shall make decisions regarding submission or exclusion.

10. Suspicions of copyright infringement should be reported to marketing@skat.com.pl

11. The participant may also encourage Internet users to vote for his/her work so that he/she attains the required minimum number of votes. Pictures that receive a qualified number of votes shall take part in the final.

§ 7. Rules for selecting the winner

1. The Contest consists of two stages.

2. In the first stage, starting on the date of the announcement of individual editions of the contest, participants submit a photograph and collect votes from Internet users.

3. All works that have attained a minimum of 10 votes pass to the second stage, called the final. Attaining more than 10 votes does not increase chances of winning.

4. The contest committee will select the winner based on the submissions selected for the final.

5. Works will be evaluated in accordance with the following criteria:

- a. reference to the subject matter,
- b. originality,
- c. creativity,
- d. perceptiveness of the author,
- e. image quality,
- f. general aesthetics.

6. The Contest Committee, appointed by the Contest Organiser, consists of 3 people - representatives of the Organiser.

§8. Announcement of Contest results

1. The winning work will be presented at www.poznajswiatzeskat.pl, the Organiser's social media profiles, and on the websites and social media of the Contest Partners within 7 calendar days of the end of the given edition of the Contest.

2. Winners will be notified via e-mail or by phone.

§9. Prizes

1. Only one winner will be selected in each edition of the Contest.

2. For **1st place** in the Contest, a prize of a value not exceeding PLN 2,000 (in words: two thousand Polish zloty) shall be awarded in the form of a two-way ferry voucher for two people between the two ports selected from among the ports on offer at www.promyskat.pl for the given edition of the Contest, within the validity period of the voucher, the date of which is set out in the voucher and in Annex 15 for each edition of the Contest.

3. A detailed description of the **prize for the 1st place can be found in the Annex to these Contest Terms and Conditions.**

4. For the **2nd and 3rd place** a set of promotional gifts or in-kind prizes are awarded.

5. The jury may also award distinctions in the form of a set of promotional gifts or prizes.

6. The ferry crossing shall take place within a maximum of 3 months from the announcement of the results.

7. **Not later than one month from the end of the ferry crossing, the Winner is obliged to prepare a photo essay consisting of a minimum of 5 photos with a short text, explaining in an interesting and positive way what places the photographs represent and how the trip progressed.** The Organiser shall acquire copyrights to the photo essay along with the text from the moment it is first made available to the Organiser and for the fields of exploitation specified in **§ 6 para. 4 and 5.**

8. Random situations that prevent receiving the prize, that is, taking part in the ferry crossing on a specific date, will be considered individually.

9. Within 24 hours after the Organiser has sent confirmation of the award, the Winner of each edition of the Competition is obliged to confirm the possibility of accepting the prize.

10. Confirmation of the possibility of accepting the prize must additionally contain the following data: name and surname, telephone number, address, identity card number or other identity document number.

11. Contest Prizes are not subject to exchange for their equivalent in money or for other types of prizes. Contest Winners cannot transfer the right to receive the prize to other people. The ferry voucher may not be sold.

§10. Final provisions

1. Participants who were found to interfere with the Internet platform used to implement the Contest or act in a manner inconsistent with the law and rules of social conduct or these Terms and Conditions may be excluded by

participation in the Contest or lose the right to the Award. All complaints in connection with the Contest should be reported to the Organiser at its address in writing along with a description of the complaint and its detailed justification within 14 days from the date of occurrence of the basis for the complaint. Complaints related to the Contest are settled by the Contest Committee.

2. The Organiser may, to the extent permitted by applicable law, change the rules of the Contest and the content of the Terms and Conditions during the Contest, including the extension of the duration or announcement of winners, of which the Organiser shall inform Contest Participants on the Contest terms and conditions pages, unless this will affect the conditions of participation in the Contest. The Organiser may announce new Contest terms and conditions before the start of each new edition of the Contest.
